Central Nebraska Housing Grant Recipients Await Release of Funds

We are proud to announce that Letters of Award have been received by the Central Nebraska Housing Developers and the Village of Wolbach for the State's 2012 Housing Grant cycle.

Central Nebraska Housing Developers will be awarded two grants, as follows:

- **Rental Rehabilitation Program** - Will provide funding to repair rental housing units in the 17-county region, to improve the health and safety of rental units for future generations. Eligible participants will be private landlords and housing authorities. Total grant funds anticipated are \$150,780.
- **Community Code Enforcement Pilot Program** - Will provide funding to communities to enforce local nuisance codes and to identify blighted and substandard properties for future demolition. Total grant funds anticipated are \$75,000.

Announcements will be made when Release of Funds have been received, and the programs are eligible to begin. If you have questions about these programs, please call Judy Petersen, CNHD Executive Director, at 402-340-0106.

Village of Wolbach will be awarded one grant, as follows:

- **Rental Rehabilitation Program** - Will rehabilitate the Village-owned 4-plex to improve the health and safety of these units for future generations. Total grant funds anticipated are \$126,795.
